We are keen interested to educate / aware Students, Women's, Youth, etc. especially about Legal issues as well as explain various law topics and their roles while dealing with situations of human rights violation and enlighten them on the critical situations.

#### 1. An Under-trails of Latur Central Jail

**Shadul Nijamoddin Shaikh (27)** belongs to very poor family of 6 members including (parents, wife & children). He was only the earning person who takes care of daily needs but unfortunately got arrested by Udgir city Police U/s 323, 324, 504 & 506 of IPC and got Jail custody. Our team interacted with him at Latur Central Jail for counseling and after Proper verification / interaction with family members; we helped him by furnishing his Cash bail amount so that he can sustain him Family as well as provided Monthly Ration.

We analyze that due to lack of Information and illiteracy, people are behind the bars for months and years and they didn't get 2nd Chance to live a better Life.

#### 2. Release to Rehabilitation a complete Work

**Vrushab Suresh Sonawne (20)** is a First time offender, who was arrested by Deonar Police U/s 380 IPC. His Family with 4 members is very poor, Father got died before 5 years and Mother is working as a domestic worker / maid in 2 to 3 houses to take care of children and manage daily needs. Vrushab is also agreeing for rehabilitation therefore after release we had send him to Youth Development Center for skill development to get self-sustain and support his Family. We wish for his bright future and try to keep away him from Crimes which is a step to develop a Crime Free Society.

### 3. After 18 Months He met with his Family..!!

While the Legal Aid Counseling in Kalyan Jail, we came to know about **Pappu Avadhlal Pandey (42)**, who is a Father of 3 daughters, lives in Plastic Tent made near the tracks of Khopoli Railway Station. Since he is in Jail his wife had faced very crucial stages for their survival from June 2017 as his Husband got arrested by Shahpur Police Station. U/s 323, 326. No one is there to take care of the Family, some local people use to help them with food and ration but wife was worried about the process to release. We had taken the matter On-board & JMFC Magistrate had consider it and order for Cash bail of 15,000/-.

Now after 18 Months he met his Family and very much happy which we cannot express..!!

A parents of Inmates (70+) living in Udgir Village, whose son is behind the bars since last 1 year in Latur Distict Jail. Nobody is there to take care of Old Parents, Father Use to sell (Moongfali & Channa) on Streets to earn money for their survival. Mother is a paralysis patient and she is not in a condition to cook food for themselves. GCF helped them by providing cash to manage for a month and working for the release of their Son (22) as he is Non-Habitual.
