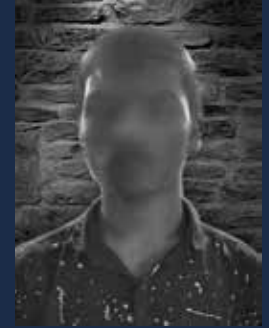

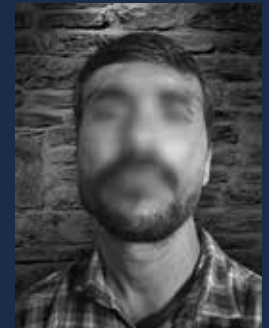
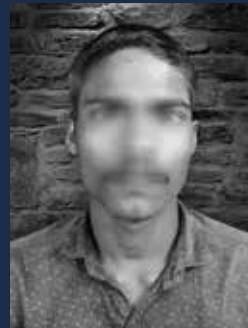
Mother of Shoeb , 37 yrs

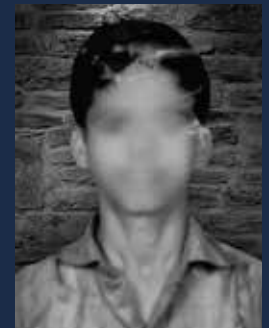
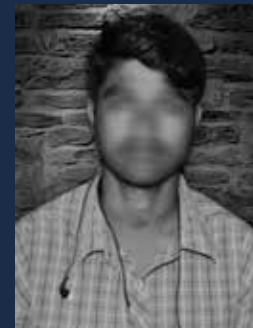
Pappu Avadhilal Pandey, 42 yrs

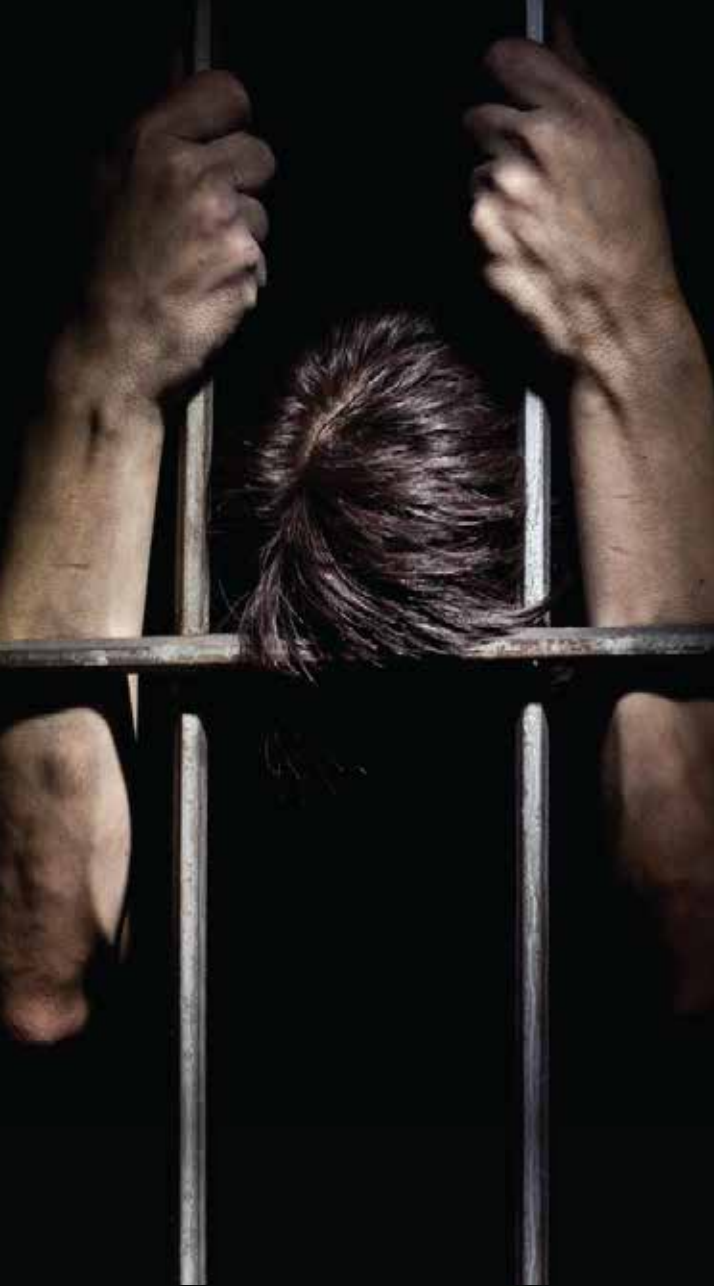

Focus Area's

PRISONERS RELEASE PROGRAM

PROVIDE LEGAL AND FINANCIAL AID

To provide Legal and Financial Aid to Non-Habitual / First time offender's, Under-Trial Prisoners who belongs to Poor / Socio-economic family background irrespective of their Caste, Creeds and Religion.

How it Works

- We have a Panel of Advocates who visit the Jails and do the counselling of Inmates.
- While the counselling process when we confirmed that Person is Non-Habitual / First Time Offender then we go ahead with Home, Police Verification Process.
- If we found genuineness from Accused Family visit and they are in need of Legal / Financial help then we process for release by Hon'ble Court.
- After release, we consult them to analysis the reason behind issue of conflict of law and try to Rehabilitate / Develop their skills / Assist for education / Job placements as per the need and circumstances with the collaboration of prominent NGO's.



LEGAL AID CLINIC

TO PROVIDE FREE LEGAL GUIDANCE /ADVICE

Especially for those who are facing Matrimonial disputes, Civil / Criminal Matters and they don't have financial backup as well as they don't find good / genuine lawyer. We help them to reach governmental schemes in legal assistance and Free Lawyer through Mumbai District Legal Services Authority (DLSA).

How it Works

- One of the primary concerns is the monetary support for all the legal proceedings.
- The Legal Aid Clinic is open for two days a week, Saturday and Sunday from 5.00 p.m. to 7.00 p.m. with prior appointment.
- We refer our panel of advocates for an effective legal remedy in case of emergency.
- We also refer cases to DLSA, if Applicant need Free Advocate to Proceed their Matters.

LEGAL / SOCIAL AWARENESS PROGRAM

As we know that, Best and Worst scenario for any community is depend upon their Youth's activity. We should work very hard with dedication to change worst seen with Legal / Social Awareness program also help them to be a good example for next generation.

How it Works

- DLSA provides yearly schedule of Awareness Program with different topics, we conducting these program as per need of the hour.
- We are keen interested to collaborate / take help of local NGO, Youth and local officials, to reach maximum people.

In short duration some of the Remarkable experience are as followed...

- Program for Transgender Community on Legal Rights.
- Social / Legal Awareness Program including topics Drug De-Addiction, Ragging, Cyber Crime, Human Rights, etc for community people and Students.
- Some vocational activity like Bag Gifted to Under Rehabilitation students and Mat Gifted at Children Observation Home etc.



PARA LEGAL TRAINING PROGRAMS

This is the basic training program to increase legal knowledge especially for educated people and Law Student so that they can help / assist to needy people to get their legal right. We conduct this program with the help of DLSA. Participants honored with Para Legal Volunteers ID card which is officially issued by Government body, District Legal Services Authority.

How it Works

- Duration of training program is 5 days
- Including Lectures by Senior Lawyers, Retired Magistrates, Government Officials and Experienced Social Workers, etc.
- Training session also includes practical visits to Police Station, Court and Prison to analysis the system.
- After Training we give assignment to participants for practice.
