Who Are We?

Global Care Foundation (or GCF), is an NGO registered under the Bombay Public Trust Act 1950, bearing Reg. No. E-33688. One of our main focus areas is providing Legal and Financial Aid to Under-trials. There are several non-habitual under-trial prisoners who have committed petty offences (and some of them have even been granted bail), but are still languishing behind the bars for long periods of time because their family members do not have access to legal aid and/or are unable to furnish the bail.

GCF wholeheartedly and dedicatedly works towards the release of these inmates. After their release, we provide them corrective counselling and try to rehabilitate them. We help them develop their skills, provide them educational assistance and also try to help them with job placements/self-employment. We have collaborated with a number of prominent NGOs that assist us in these matters.

REUNITING AN ILL MOTHER WITH HER YOUNG CHILDREN

Giving a mother a 2nd chance

The misery of prison life coupled with the pain of separation from her children, made Afreen Ansari's survival more painful. Her assault was emotionally geared as her husband was involved in an extra-marital affair. She tried to convince her husband and the other woman to stop, but they did not. The dispute escalated, and a frustrated Afreen resorted to violence.

She was arrested U/s 307 of the IPC in June 2017. She lived in distress behind the bars for 2 years at Adharwadi, Kalyan Jail. Her children Kulsum (7) and Shahid (5) were hopeful of her release and they waited for their mother to return home. GCF studied and verified her case. We took her poor financial condition, ill health (HIV+) & the pitiable, neglected state of her kids into consideration and paid her cash bail amount of Rs. 25,000/-. We felt that she deserved a second chance to live a decent life. We are now working towards providing her medical and employment assistance.

FROM LAWLESS OFFENDER TO LAW-ABIDING CITIZEN

One girl's conscious decision to change.

Society plays a major role in the making of a criminal. This is the case of a young girl Priya (20), who unfortunately got into bad company during her college days. As a result, she got into the habit of smoking and taking drugs. In January 2019, her intoxicated husband got into a terrible dispute with his family. Things got out of hand after the parties to the dispute started abusing & physically assaulting each other in the presence of Police, for which both got arrested U/s 353, 427, 504, 506, 34 IPC.

During the span of 8 months behind the bars, Priya had time to reflect upon her deeds. She gained a new perspective about life, studied and appeared for the HSC examination. She passed with flying colors while she was in Kalyan Jail. We were pleased with her transformation. Her family consisting an uncle, aunt and a younger brother who is mentally & physically disabled, could not afford to furnish her bail. GCF helped and paid the bail amount of Rs. 15,000/- towards her release. GCF is assisting her with free skill development courses and is helping her set goals for herself.

RELEASING A TERMINALLY ILL OFFENDER

Helping those who need it the most

Nasreen Mulla was accused of selling children to those couples who were looking to adopt. She was arrested U/s 363, 365, 370 of the IPC and put in Byculla jail. Nasreen is HIV+ & suffers from cancer, last stage TB and is also paralyzed. Life in jail was extremely difficult and took a terrible toll on her health. She was granted bail by the court.

Prayas, a project of TISS, referred her case to GCF at the request of the Jail Superintendent. GCF studied her case thoroughly. We took her extreme ill health into consideration and got her released by paying her bail amount of Rs. 10,000/-. She had spent 4 years in jail. She was counselled and is currently in her native place and being looked after by her relatives.

A RELEASE TO REHABILITATION STORY

Details of the offender: Murad Shaikh, Male - 34.

Offence: Petty Theft

Members in the family: Himself, Wife and 2 Children

Case Description: Unable to cope with extreme poverty, a distressed Murad, who is physically handicapped, tried to steal a phone from a running train and was caught and arrested.

Issues Faced: With their sole earning member behind the bars, the family lived in impoverishment and misery. They had barely enough food to survive. They had no access to legal aid and had absolutely no way to furnish Murad's bail amount.

Arrested U/s: 392, 150 (E) IPC

Duration in jail: 16 Months in Kalyan Jail.

How GCF helped: We studied his case and realized that it was extreme destitution that led Murad to commit the crime. We paid for his bail amount and had him released. We counseled him and made sure he was repentant of what he had done. We also worked on his complete rehabilitation. He was unable to find a decent job because of his handicap, hence we set up a Sandwich and Tea Stall for him so that he can sustain himself and his family.

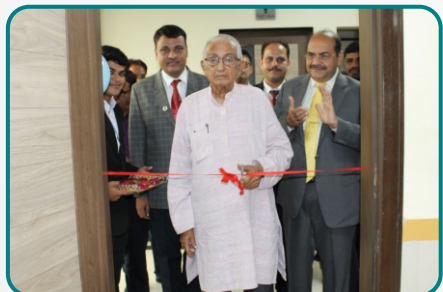

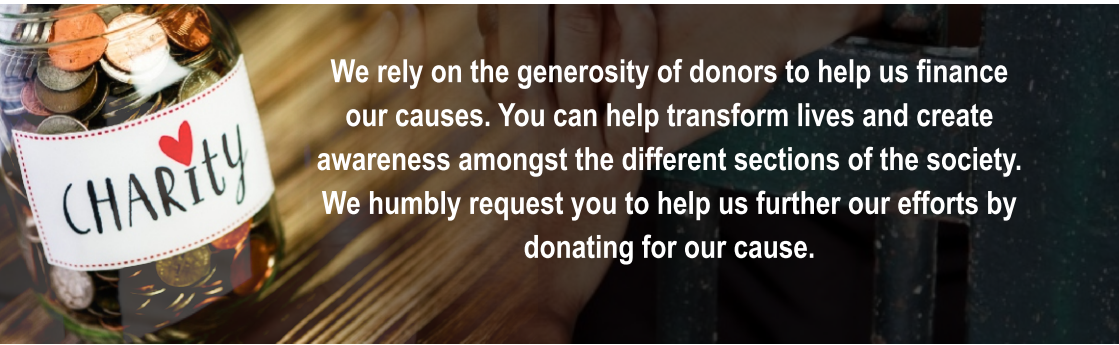
