

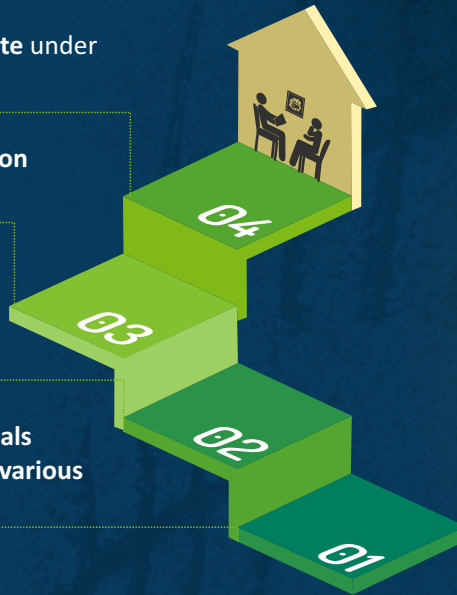

Our Focus areas are releasing Non-Habitual Under-Trials by providing Legal and Financial Aid, and after their release assisting them with counselling, rehabilitation and skill development, Conducting Legal/Social Awareness Programs for the public at large, providing free legal guidance to people in need of assistance through Legal Aid Clinics, and organizing Para-Legal Training Programs. We have a team of committed professionals including Advocates, Doctors, Counselors, Psychiatrists, etc. who work wholeheartedly towards furthering our cause.

CASES WORTHY OF MENTION

HELPING A POOR WOMAN REUNITE WITH HER SMALL CHILDREN

Shilpa Kale,* (F,27), a divorced food delivery girl having one children, working to feed many mouths in her family, was arrested after a verbal spat with the traffic police authorities last year. She was the breadwinner of the family and after her arrest the family was left with no source of income. She spent around 1 year in Byculla Prison leaving one child behind.

Rs. 15,000 was been paid by GCF towards her cash bail of the total Rs. 25,000.

RETURN OF A POOR MAN TO HIS FAMILY AFTER THE PAINFUL LOCKDOWN

Nasir Khan,* (M, 29) on charges of theft, which were claimed to be false as per his family, was arrested by Dharavi Police and was languishing behind the bars in Arthur Road Jail for last 8 months. His economic condition is deplorable and after his arrest his pregnant wife was forced to sell AndaPav as a means to feed the other two children.

GCF helped to release him by paying Cash bail amount of Rs. 15,000.





RELEASE OF AN OLD WOMAN TO SUPPORT HER FAMILY AGAIN

Qamrun Nisa Shaikh,* (62, F), an old lady hailing from a poor household was arrested under the NDPS Act. During the lockdown, her ailing son who has been suffering from hemorrhoids and worked as an auto driver lost his job. She languished behind the bars for 1.5 years and then was released by GCF by paying Rs. 25,000 cash bail. The family's financial condition still remains in shambles.



THE SAD PLIGHT OF THE FAMILY LIVING ON THE STREETS

Vinayak Chander Singh*, (M, 24). used to live on the streets near Bandra Talao. He was arrested U/S 380, 471 IPC and was languishing behind the bars for 1.6 years. Since he was in the, the sole breadwinner of the family who made a living by collecting garbage and segregating plastic from it. His 65 year old mother was forced to beg on the streets in the absence of her son especially during the lockdown. The family used to wrap themselves in plastic because they didn't have any bed sheets to sleep upon. Global Care Foundation paid Rs. 15000 for his cash bail looking at the extremely poverty stricken condition of his family.


NATION LEGAL SERVICES DAY CELEBRATION AT FAMILY COURT – BANDRA

5) The approval is granted subject to the following conditions:


