Our Focus areas are releasing Non-Habitual Under-Trials accused of petty crimes by providing Legal and Financial Aid, and after their release assisting them with counselling, rehabilitation and skill development, Conducting Legal/Social Awareness Programs for the public at large, providing free legal guidance to people in need of assistance through Legal Aid Clinics, and organizing Para-Legal Training Programs. We have a team of committed professionals including Advocates, Doctors, Counselors, Psychiatrists, etc. who work wholeheartedly towards furthering our cause.

The post pandemic and lockdown effects are by and large written all over the place and many are grappling for survival.

## **ACTIVITIES**

### NOTABLE CASES OF THE QUARTER

#### 1. Reuniting A Helpless And Ill Mother With Her Children


**Ruksana Shaikh\*** (30, F) a poor woman living on the streets and having three children was arrested U/s 363 and 368 of IPC. She has been in Byculla jail for 7 Months with her one year old child and is suffering from Tuberculosis. Her father resides at the native place and no one was there to furnish the bail. Global Care Foundation helped her with Rs. 7000 and furnished her cash bail.

### 2. Return of A Bangladeshi Woman To Her Bereft Daughter

Razia Nasir Shaikh\*, (40, F) arrived in Mumbai with her two children in search of work two years ago. She and her 16 year old daughter worked as house helps to eke out a living. Some lady befriended the daughter and tried to sell her off. The police rescued the children while Razia and the other woman were arrested on human trafficking charges, and lodged in Thane Jail. She spent 1.8 years in jail before Global Care Foundation helped her with Rs. 15000 cash bail amount and reunited the mother and daughter duo.

### 3. Release of An Auto Driver Arrested For A Fight With His Friend

**Shahid Ansari\***, (27,M) lodged behind the bars of Kalyan jail from last 2.4 years, an auto driver had an argument with his friend which erupted into a fight and based on the injury sustained by his friend, he was arrested. Due to financial incapacities, the family couldn't get him released ever since his arrest. He had a surety bail which GCF got converted into cash bail. His father, a salesman, the sole breadwinner of a 5 membered family was in extreme financial crunch to have his son released. Global Care Foundation paid Rs. 5000 towards his bail of Rs. 15000 the remainder of which was arranged by the family and got him released.



### **AFTER RELEASE CARE**

#### 1. Financing And Setting Up A Tailoring Unit For A Mother Son Duo

Abdullah Shaikh\* was released by Global Care Foundation's efforts during the lockdown. Owing to the lockdown the financial condition of the family deteriorated to the extent that basic survival was a trouble. Since the mother and son are skilled to sew, Global Care Foundation helped them in setting up a humble tailoring unit with a sewing machine, all necessary tools, needles and threads, and some fabric to start off. This initiative shall help them earn their own livelihood. The cost of the setup is Rs. 10000/-.



### 2. Setting Up of A Small Shack For A Poor Couple Who Were Released

A couple, Nuzhat\* and Majid Shaikh\* after spending much time behind the bars during the lockdown, after their release had no source of income. While they were imprisoned, their four children were begging on the streets for survival. With each passing day their condition was only getting deplorable and the financial crisis was mounting on the couple. Global Care Foundation helped the family to set up a small shack in their locality for a source of daily livelihood. The cost of the shack setup is Rs. 5000/-.

### ACTIVITY ADD-ON

- 1. 70 houses were provided with trampoline roofs in Chembur after the Tauktae cyclone blew away their shelters.
- 2. Ever since the Tauktae cyclone has washed away the houses in Chembur, GCF along with other NGOs has been providing cooked food to the people. 500 people are being served daily for the last two months.
- 3. A dry ration distribution drive was carried out in Nagewadi area of Chembur, and 200 kits were distributed to the local poor people.
- 4. An awareness program was held in Dharavi for the slum dwellers. Shri. Wani Secretary of District Legal Services Authority Mumbai, addressed the people by giving them an introduction to DLSA along with explaining to them about the various schemes of the DLSA and the government. Ration was distributed to the attendees.
- 5. Medical help provided to a cancer patient (Rs. 5,000) and another patient in Saifee hospital was provided Rs. 10,000 as help.





### COVID RELIEF

The onslaught of the pandemic has not spared any one. It has taken everyone in its sweep to create disruption and destruction of all kinds. Life has just turned into a mere game of survival with the indigent and needy being left with no means of livelihood or even square meals. Global Care Foundation yet another time helped 15,500 families through a massive grant of Rs. 2,02,47,650 from Azim Premji Foundation.
