STATS OF PRISONS

- The occupancy rate of prisons in Maharashtra is 154.3% for males i.e. 12,400 inmates are extra over the given capacity thus making them extremely overcrowded.
- Under-trials in Maharashtra itself are a whopping 27,557.
- The highest number of under-trials are in the productive age group of 18-30 years.
- Roughly 50 percent of under-trials in Maharashtra have education below tenth grade.

Reshma Nikhil Shaikh

In Jail: 1.8 Years | Thane Central Prison

Reshma fell into a trap of a human traffickers who were trying to sell off Reshma's daughter Hajira. She was arrested along with the other miscreants.

"Hum Bangladesh se hai, jab jail gaye to koi ummeed nahi thi ki wapas kabhi ghar ja payenge. Ye bhale log aaye aur mujhe bahar nikale Eid se pehle."

Asida Bibi Umar Mulla

In Jail: 1.8 Years | Byculla District Prison

Asida came to Mumbai with a few acquaintances in search of work and was arrested while she was having a stroll at Juhu beach since one person from her group was caught chain snatching at Borivali station.

"Bohot hi takleef me din nikale hai jail me. Corona ke karan sirf biscuit pe Zinda rahe. Har chiz ke liye bohot pareshani thi"

Hannan Shaikh

In Jail: 3.6 Years | Thane Central Prison

In a dispute with his client's neighbour, Hannan was arrested on charges of POCSO Act. Having spent close to 4 years in jail, he had given up hope of returning to his 23 membered family.

"Pichli teen Eid maine jail me guzari bilkul akele. Biwi bachon ko dekhne taras gaya tha.." 10 days before his release, his wife passed away.

Deepak Mandal

In Jail: 10 Months | Thane Central Prison

Deepak was arrested for molesting his own wife. KEM hospital authorities alerted the police without verifying the truth when Deepak took his pregnant wife to the hospital for treatment.

"Kabhi nahi socha tha ki aisa hoga. Meri patni ko bohot mushkilon ka saamna karna padha jab mai jail me tha. Apne bache ko bhi mai dekh nahi sakta tha jail me.."



FOCUS AREAS

Prisoner Release Program

Release of non-habitual under-trials hailing accused of petty offences from underprivileged households by paying their cash bails and rehabilitating them after release to resume normal life.

Free Legal Aid Clinic

Providing free legal guidance through legal experts in matters of domestic violence, matrimonial discords, property disputes, criminal offences, etc. Appropriate legal advice is given at the various Legal Aid Clinics.

Legal & Social Awareness Program

Legal and Social Awareness Programs are conducted and organised for different factions of the society based on the need and requirement. Expert speakers are invited for the deliverance on the subject matter.

Para Legal Training Program

To create a bridge between the common man and the law enforcement agencies and the judiciary, social enthusiasts are trained through the NALSA designed training program and Paralegal Volunteers in the society are generated.

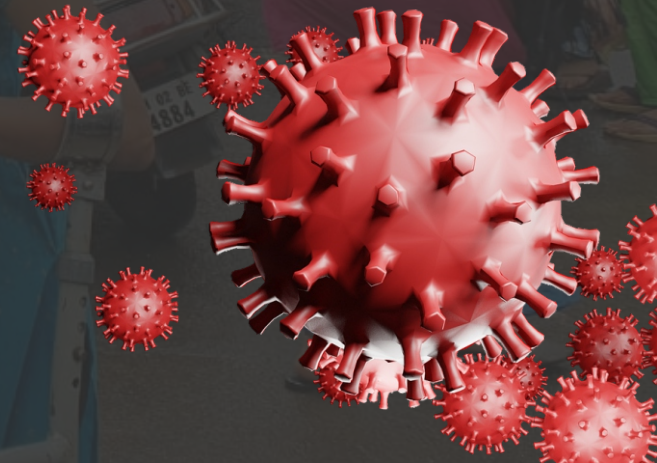

The children in the Observation Home can learn new skills during their stay and use the same skills for livelihood once they are released from the facility. 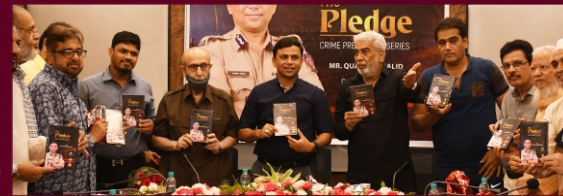

75TH AZAADI KA AMRIT MAHOTSAV CELEBRATION

India entered into 75th year of independence and a nation-wide celebration has ensued under the aegis of Ministry of Culture. As a part of the celebration drive, under the guidance of District Legal Services Authority, Mumbai and Mumbai Suburban, GCF conducted 10 legal awareness programs in different areas of Mumbai. The programs highlighted Rights of Women, Rights of Elderly, Legal Remedies for the underprivileged sections of the society, various Government and NALSA schemes for the penurious sections of the society, etc.



GCF was fortunate to have participated in the Mega Legal Services Camp held in Bandra by the joint collaboration of Collectorate, Mumbai and Mumbai Suburban and DLSA, Mumbai and Mumbai Suburban.

GCF had a stall amidst other government body and NGO stalls in the camp and the stall was inaugurated at the August hands of Hon'ble Justice A. A Sayed, Justice Sadhna Jadhav, Justice R. D Dhanuka, Justice Bisht, and many other eminent personalities.





1ST IN-HOUSE DE-ADDICTION CENTER IN MAHARASHTRA

A first of its kind De-Addiction Center for 15 juveniles has been started in the Observation and Children Home, Dongri through an officially allocated spaced within the Children Home premises. The center has been equipped with the best professional staff to help the children recover from the addiction as well as quality paraphernalia is housed in the center.

The De-Addiction Center shall cater to all those children who are housed in the Observation Home that have underlying issues of substance or alcohol abuse along with underlying co-morbid psychiatric issues such as Learning Disability, Asperger's Syndrome, ADHD, PTSD, Depression, Mania, Anxiety, Bipolar Disorders, etc.



It has been understood that these problems arise in children due to the broken and bad family structures as well as well the lack of awareness in their families about such disorders and hence children fall prey to addictive substances which in turn leads to criminal activities.

The De-Addicton Center shall serve as a Counseling and Therapy Center that shall motivate the children and help them rise above the substance/alcohol abuse so that they can return to normal life and transform into responsible and productive youth of the country.





PROJECT H.E.A.L - HANDY AND EASY ACCESS TO LEGAL AID

Project H.E.A.L has been designed to heal the legal wounds of the common man. H.E.A.L is a socio-commercial initiative aimed to standardise legal fees for the needy and underprivileged people.

H.E.A.L provides a unified platform for advocates; those that want to learn and explore while the other established lot who wish to help people with their expertise.

H.E.A.L will help people find easy solutions to their legal problems without having to worry about the costs involved. Article 14 shall be enforced in its true sense through the Project H.E.A.L so that the deserving get access to justice.

The main intent to start Global Care Foundation was to explore the world of crime prevention as I felt great lacking in the society as to Legal Aid and Awareness. I observed that not many are sensitised in this domain and took upon myself to venture into the least worked upon area.

The lack of appropriate legal guidance and awareness has caused a huge population, especially belonging to minorities, who are underprivileged and downtrodden land up in jails.

Global Care Foundation was born in 2017. Five years ago, we were three trustees and one staff member who began working at changing lives of the needy and penurious. With the passage of time, the organisation started growing in terms of activities as well as staff.

Although, we are still a small team of people, the achievements were enough to make heads turn. In the little span of time, we have been prosperous to have released 242* undertrials on cash bail. These undertrials are first time offenders who have been imprisoned for years for want of mere ten to fifteen thousand rupees.

Since we function in a niche area of crime prevention through various means, people high and low have appreciated our work and we have garnered immense support from the community.

I envision to go nation wide while working at the grassroots level and strive each day by making differences to lives that matter.

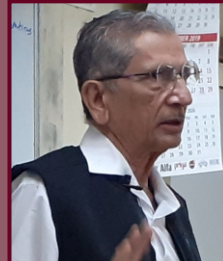
