INTRODUCTION

Global Care Foundation, is an NGO registered under the Bombay Public Trust Act 1950, bearing Reg. No. E33688. Our Focus areas are releasing Non-Habitual Under-Trials accused of petty crimes by providing Legal and Financial Aid, and after their release assisting them with counselling, rehabilitation and skill development, Conducting Legal/Social Awareness Programs for the public at large, providing free legal guidance to people in need of assistance through Legal Aid Clinics, and organizing Para-Legal Training Programs. We have a team of committed professionals including Advocates, Doctors, Counselors, Psychiatrists, etc. who work wholeheartedly towards furthering our cause.

ACTIVITIES

● NOTEWORTHY CASES OF THE QUARTER

1. Release of a daily wage earner who picked up a feud in lieu of his contractor

Abdul Mannan Shaikh (30, M), a daily wage labourer, was contracted to build a shanty in his locality. The place where he had to build, the neighbors got into a fight with him rather than the owners. In this due course, the neighbours alleged before the police of child abuse and he was arrested on 21.04.2018 under POCSO and lodged in Thane Jail.

He was the sole bread winner of his family consisting of a 3 children and his wife. During his stay in the jail his wife started living with her parents, made boxes for a living and ten days before his release passed away leaving the children with her parents. His parents are too old and poor and his younger brother took care of the entire 21 membered family, therefore they could not furnish his bail or pursue legal proceedings ever since his arrest in 2018.

Global Care Foundation paid Rs. 15000 towards his bail and he was released after a mighty 3.2 years.

2. Release of a woman arrested for being an accomplice

Rashida Bibi*, (29, F), came to Mumbai in search of work with a few acquaintances from Kolkata. While she was having a stroll at Juhu beach with a friend, the others from their group committed chain snatching and upon being arrested named the two on Juhu beach as well.

Rashida was arrested U/S 395 IPC, and lodged in Byculla jail since 15th December 2019. She is a divorced lady where her two little children are with Rashida's mother in Kolkata while she was in jail in Mumbai.

Since she had no family or means to pay her bail, Global Care Foundation paid Rs. 15000 towards her bail and she was released after 1 year and 8 months along with her children.

3. An orphan reunited with his lone brother

Sameer Ali*, (21, M), lost his mother in early childhood and when he was around 10 years his father went missing and never returned. He and his younger brother lived by rag picking.

Sameer fell in love with a girl in the neighborhood and who was below 18 years. They intended to get married but the girl's family was against their relationship and filed an FIR against him U/s 376 (1) A, 376 (3), 363 IPC and various sections under POCSO Act.

He secured a bail after seven months of his arrest but since his brother couldn't help pay the amount he continued in jail for around 2 years.

Global Care Foundation paid his cash bail amount of Rs. 15000 and got him released after almost spending 2 long years in the jail.

4. Release of a poor labourer and breadwinner arrested on grounds of raping his wife

Dinesh Mandal*, (28, M), a resident of Malad, sole breadwinner of the family, was arrested by Kurar Police U/s 376 IPC and POCSO after speculations that he had raped his wife.

Dinesh's wife, Rashmi, is an orphan and after fixing of her marriage with Dinesh, her old grandmother passed away. Dinesh and Laxmi got married by way of customary Hindu rituals and proceeded with their married life. Rashmi in due course was pregnant and around the fifth month of pregnancy developed some kidney disease wherein Dinesh took her to KEM hospital for treatment. The doctors after learning that she is pregnant alerted the police as they speculated Rashmi to be a minor.

After Dinesh's arrest, since the family was already distraught, did not have any advocate representation, which GCF provided. GCF's advocate applied for bail, but owing to the pandemic it took some months until the bail order was pronounced. The advocate then made a modification and reduction application to the surety bail order and was successful in securing a cash bail order.

The family paid Rs. 7500 towards the Rs. 15000 cash bail, the remainder of which was furnished by Global Care Foundation and he was released.
