Sahil Ahmed\*, (12,M), a 7th standard student and son of a poor vegetable vendor of Mumbai slums, was lodged in Children and Observation Home, Dongri in July 2022 when his neighbour suspected that Sahil was molesting his younger sister while the parents were away at the hospital for the mother's delivery.

A case was instantly filed by the police before the parents could explain anything. Since the family is huge consisting

of 17 members and his father the only breadwinner, it was difficult for the family to pay towards his bail.

Global Care Foundation stepped ahead to help him and paid Rs. 5000 and got him released. He shall go back to school while we are looking for better livelihood opportunities for his father.

## Release of a man arrested for theft committed due to poverty

**Dinesh Korde\***, (32, M) worked as a security guard in Virar. He lives with his old mother who works as a helper in Bombay Hospital and one brother who also is a watchman.

While finances were tight, Dinesh's employer didn't pay his salary on time and he was in dire need of money for treatment. Under such conditions he was tempted to steal a mobile phone to meet his needs.

He was arrested and lodged in Arthur Road jail. His mother and brother could not arrange for his bail as what they would earn would

be spent in household expenses as well as rent and medicines. **Global Care Foundation stepped ahead to help him and paid Rs. 15000 and got him released.**

Vishal Kale\*, (32, M), a divorcee and worked as a security guard and lived in the society office.

He had rented a house after he fell in love with another woman after his divorce and started to live with her. She registered a case against him for eve-teasing.

He was arrested and lodged in Thane Jail. There he skilled himself as a painter with certification.

With the support of his

employer who wanted him to get bail, **Global Care** Foundation intervened and paid his cash bail amount of Rs. 15,000 and he was released.

He has started to work as a painter under the same employer as well as is back to his employment of security guard.

One day, he got into a fight with his neighbour who alleged Isa had stolen a mobile phone. A case was registered and Isa was lodged in Thane Jail.

While he was in jail, the family went through extremely troubled times and his eldest son started working to support the family. His daughter passed away due to illness when he was in jail. They had no means to furnish the bail

Global Care Foundation helped him to get released after a year of his arrest by paying Rs. 10,000 cash bail amount.

He has returned to his job of driving and shall strive hard to meet his family's needs.

## Awareness on Introduction to District Legal Services Authority


