# **HEAR OUR BENEFICIARIES**

#### Naeem Ansari In Jail: 13 Months | Kalyan District Prison

Naeem was accused of assault on a young mischievous boy of his locality who kept teasing Naeem for leading an addiction free life. Naeem went to jail and the family had no means to help him out until they approached GCF.

"Court ki karwayi me bohot der lagti hai hume ab samjha hai. Aapne bohot mehnat ki hamare case me take hamara bhai riha ho sake. Hum bohot pareshan the ek saal se"

#### Dhanashri Satish Bhosle In Jail: 1 Week | Byculla District Prison

Dhanashri was frantically looking for a stable job for her husband when some local agent told her that if she paid 3 Lakh her husband would get an assured government job. She conveyed the same to other people in the locality who also paid the amount to the agent. The agent fled and the locals filed a case of fraud and cheating on Dhanashri.

"Mere pati job par nahi the aur wo agent saare hamare paise leke bhag gaya tha. Aapki sanstha ki madad se mai jail se bahar aa saki. Mere do chote bachon ka pata nahi kya hota agar mai jail me fas jati."

#### Raghvendra B. Dasari In Jail: 4.5 Years | Kalyan District Prison

Accused of auto theft while himself being looted on his way back from work, he had no one to help him in jail for 4.5 years. His old mother working as a maid had no money and did not know how to help him.

"Aapne hamari bohot madad ki. Jail me koi puchne wala nahi tha. Maine umeed chod di thi ki mai ghar wapas ja sakunga.."

#### Mohabbat Ali Mohamed Abdulla Mir In Jail: 4 Month | Kalyan District Prison

Mohabbat, a TV artist lived alone and loved animals. He was opposed by the locals of the area for feeding stray dogs and one such person was also his girlfriend's father. There was a heated argument between Mohabbat and the girl's father after which the father accused him of molestation and abuse of his daughter and Mohabbat was arrested.

"Meri koi family nahi hai. Aap jail me na milte to mai aise hi andar pada rehta. Aap ka bohot bohot shukriya ke aapne meri madad ki"



## 🔘 Medical Camp at Yerwada Central Prison – 1100 inmates diagnosed in a day



# FIRST IN INDIA

## In-house De-addiction, Counseling And Therapy Center For Juveniles In Conflict With Law At Observation And Children Home, Dongri

A dedicated **15 bedded** deaddiction facility for children in conflict with law, PARHEZ was started by Global Care Foundation in May, 2023 at the Children's Observation Home, Dongri, Mumbai under the able guidance of **Juvenile Justice Committee - Bombay High Court**, in collaboration with Department of Women and Child Development and Children Aid Society.

#### **Process of treatment:**

- 1. Admission after counseling of probation officer and through court order only.
- 2. Expert psychiatric evaluation and prescription of medication as required
- 3. Regular psychological counseling for behavioral improvements
- 4. Different types of activities including education, learning life skills, sports, exercise, and skill development, etc. to keep them engaged daily
- 5. After observation during 8-12 weeks of the Deaddiction Program providing legal aid to be released on bail from the Observation Home.

## More than 35 children treated successfully and sent home.

# PROJECT

## 50 Hour Mental Health Facilitator Training Program

Project SATHI has started in Yerwada Central Prison where a batch of highly educated convicts (Ph.D's, lawyers, engineers, science post graduates, etc.) serving long sentences are being trained to become mental health facilitators i.e. SATHIs to work on the mental health issues of the fellow inmates.

#### Project SATHI shall work as under:

- a. Training 40 educated inmates as certified mental health facilitators.
- b. Remunerating the facilitators for a year of counseling service.
- c. Facilitators will provide continuous counseling to prevent mental health issues among undertrials, reducing the risk of suicide.
- d. Conducting a comprehensive one-year program analysis to identify mental health factors within the prison.
- e. Presenting a researched report with policy-level recommendations to authorities.

#### 29 highly educated convicts successfully completed the training program.

The lack of appropriate legal guidance and awareness has caused a huge population, especially belonging to minorities, who are underprivileged and downtrodden land up in jails.

Global Care Foundation was born in 2017. Five years ago, we were three trustees and one staff member who began working at changing lives of the needy and penurious. With the passage of time, the organisation started growing in terms of activities as well as staff.

Although, we are still a small team of people, the achievements were enough to make heads turn. In the little span of time, we have been prosperous to have released 500+\* undertrials on cash bail. These undertrials are first time offenders who have been imprisoned for years for want of mere ten to fifteen thousand rupees.

Since we function in a niche area of crime prevention through various means, people high and low have appreciated our work and we have garnered immense support from the community.

I envision to go nation wide while working at the grassroots level and strive each day by making differences to lives that matter.


