Saeed Ansari*

In Jail: 4 months | Mumbai Central Prison (Arthur Road)

Saeed was accused of harassing a teenage girl in her locality who kept teasing him every day. He was arrested and his family living in Bihar were in dire circumstances.

'Aapne shuruwaat se madad ki hai meri. Court ki karyawahi ko jitni tezi se kar sakte the aapne kiya hai. Hume to samajh hi nahi aa raha tha ki kis tarah bahar aaye'

Avesh Shaikh*

In Jail: 3.5 months | Thane Central Prison

Avesh was accused of hitting his own father after which he was arrested. The incident occurred due to a misunderstanding and the whole family suffered.

'Abba ke sath jhagda hua tha aur abba ko lag gayi. Hospital walon ne police bula liye aur mujhe arrest karwa diye. Aaplog nahi aate to mai abtak jail me hi rehta'

Farzana Pathan*

In Jail: 15 days | Byculla District Prison

Farzana was co-accused of stealing gold from a house and selling it while she maintains that she was helping her friend to sell gold which she was not aware was obtained through theft.

'Mere ghar me 8 log hai meri kamayi par nirbhar. 15 din me hi ghar ke haalaat kharab ho gaye. Aapki waqt par madad ne bohot raahat di hai poore parivar ko.'

Bhagyashree Kale*

In Jail: 7 years | Kalyan District Prison

Bhagyashree was accused of murdering her husband who got into a fight with her brother and during the fight, her husband died due to injuries.

'Bail hokar bohot waqt ho chuka tha. Mera bhai aur maa bhi mere sath jail gaye. Humko madad karne wala koi nahi tha. 7 saal jail me guzarne ne ke baad hum teeno ne ghar dekha hai aapki madad se'

The main intent to start Global Care Foundation was to explore the world of crime prevention as I felt great lacking in the society as to Legal Aid and Awareness. I observed that not many are sensitised in this domain and took upon myself to venture into the least worked upon area.

The lack of appropriate legal guidance and awareness has caused a huge population, especially belonging to minorities, who are underprivileged and downtrodden land up in jails.

Global Care Foundation was born in 2017. Seven years ago, we were three trustees and one staff member who began working at changing lives of the needy and penurious. With the passage of time, the organisation started growing in terms of activities as well as staff.

Although, we are still a small team of people, the achievements were enough to make heads turn. In the little span of time, we have been prosperous to have released 1000+* undertrials on cash bail. These undertrials are first time offenders who have been imprisoned for years for want of mere ten to fifteen thousand rupees.

Since we function in a niche area of crime prevention through various means, people high and low have appreciated our work and we have garnered immense support from the community.

I envision to go nation wide while working at the grassroots level and strive each day by making differences to lives that matter.

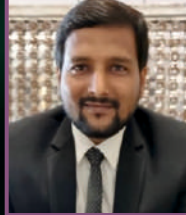

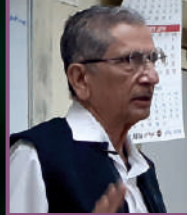
